RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of November 19, 2020 (this "Release"), is made by Zions Bancorporation, N.A. dba Amegy Bank, as administrative agent (the "Administrative Agent") for the benefit of GRIFFIN DEWATERING, LLC, a Delaware limited liability company ("Griffin Dewatering"), GRIFFIN DEWATERING CORPORATION, an Alabama corporation ("GDC"), and GRIFFIN PUMP & EQUIPMENT, LLC, a Delaware limited liability company ("Pump" and together with Griffin Dewatering and GDC, each a "Grantor" and collectively, the "Grantors"). Capitalized Terms not defined herein shall have the meanings attributed to them in the Security Agreement (as defined below).

WHEREAS, pursuant to the Credit Agreement dated as of November 22, 2013 (the "Credit Agreement") among the Griffin Intermediate Holdco, LLC, a Delaware limited liability company (the "Borrower"), the Lenders party thereto and the Administrative Agent, the Lenders agreed to make loans to and make other extensions of credit on behalf of the Borrower; and

WHEREAS, in connection with the Credit Agreement, the Debtors and the Administrative Agent entered into an Security Agreement, dated as of November 22, 2013 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), a copy of which was recorded with the U.S. Patent and Trademark Office on November 23, 2013 at Reel 5159; Frame 0936;

WHEREAS, pursuant to the Security Agreement, each Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in all of Grantor's right, title and interest, as applicable, in and to all Trademarks, Patents and Copyrights, including but not limited to those listed on Schedule A hereto (collectively, the "Collateral").


WHEREAS, the Administrative Agent acknowledges that the conditions for termination of its security interest in the Collateral have been met, and accordingly, the Administrative Agent has agreed to: (i) release all of its security interest covering the Collateral; (ii) restore all right, title and interest in and to the Collateral to the relevant Grantor; and (iii) dissolve any and all liens and encumbrances respecting the Collateral under the Security Agreement or otherwise.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby releases and terminates in its entirety its security interest in the Collateral, and discharges, quit claims, and relinquishes unto the Grantors, and re-assigns to the Grantors, any and all right, title and interest it has in and to, the Collateral. The Administrative Agent authorizes the recordation of this Release by any Grantor or such Grantor's agent.
