PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of November 20, 2020 (this "Partial Release") is made by TRUIST BANK (as successor by merger to SunTrust Bank), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Secured Parties (as defined in the Security Agreement referred to below) in favor of Central Garden & Pet Company, a Delaware corporation (the "Grantor").

Pursuant to the Security Agreement, dated as of December 5, 2013 entered into by the Grantor, certain of its affiliates, and Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor and Administrative Agent entered into a certain Trademark Security Agreement, dated as of December 5, 2013 and recorded in the United States Patent and Trademark Office on December 20, 2013, at Reel 5178, Frame 0831 (the "Trademark Security Agreement"), and pursuant to the Security Agreement and Trademark Security Agreement, Grantor granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under certain Trademark Collateral (as defined in the Trademark Security Agreement) identified on Schedule A hereto and incorporated herein by reference.

The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the grant of and all of its lien on and security interest in, all right, title and interest in, to and under said certain Trademark Collateral granted under the Trademark Security Agreement identified on Schedule A hereto and incorporated herein by reference. Any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Administrative Agent's security interest in any intellectual property or any other asset of the Grantor other than the certain Trademark Collateral identified on Schedule A hereto.

3.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by Grantor to effect the release of the security interest contemplated hereby, at Grantor's expense. The Administrative Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Partial Release with the United States Patent and Trademark Office.

4.

This Partial Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one

and the same agreement. Delivery by telecopier or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.
