1. **Assignment.** Pursuant to that certain Asset Purchase Agreement among Assignor, Assignee, Steven Kantor, and the other members of Assignor dated as of November 13, 2020 (the "APA"), effective as of the Effective Date (as defined in the APA), Assignor does hereby assign, transfer and convey to Assignee, and Assignee does hereby accept from Assignor, all worldwide rights in the TM&C, together with the right to bring and prosecute any claims or causes of action for past infringement of the TM&C.


