TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement"), effective as of this 22nd day of April, 2015 (the "Effective Date"), is by and between Project 18, LLC, a New York limited liability company ("Assignor") and IFG Corp., a New York corporation ("Assignee").

I. BACKGROUND

A. Assignor is the owner of the trademarks and/or service marks shown in attached Exhibit A, and any and all trade dress associated therewith (collectively, the "Marks"), together with the goodwill of the business symbolized thereby in connection with the goods and services on which, or in conjunction with which, the Marks are used (the "Products/Services").

NOW, THEREFORE, Assignor and Assignee, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

II. AGREEMENT

2.1 For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's worldwide right, title, and interest in and to the Marks, together with (1) the goodwill of the business relating to the Products/Services upon which the Marks are used, or in conjunction with which the Marks are used, and for which they are registered or for which applications have been filed; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Marks, including but not limited to damages, and payments for past or future infringements and misappropriations of the Marks; (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks; and (4) any other rights related to the Marks.

2.2 Assignor further conveys, transfers, assigns, delivers, and contributes to Assignee all rights in the trade dress, labels, logos, designs and domain names associated with the Marks.




