TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS

(Pollo Operations, Inc.)

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS (this "Release"), is made by JPMorgan Chase Bank, N.A., a national banking association, as administrative agent ("Administrative Agent"), in favor of Pollo Operations, Inc., a Florida corporation ("Grantor"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreements or the Security Agreement, as applicable.

WHEREAS, pursuant to that certain First Amended and Restated Pledge and Security Agreement, dated as of July 10, 2020, among Grantor, certain affiliates of Grantor, and Administrative Agent (such agreement, as said agreement may have been amended and in effect from time to time, the "Security Agreement"), Grantor granted to Administrative Agent a security interest in substantially all the assets of Grantor, including the Released Trademarks.

WHEREAS, pursuant to that certain (i) Trademark Security Agreement, dated as of November 30, 2017, between Administrative Agent and Grantor, which was recorded in the United States Patent and Trademark Office on November 30, 2017, as against certain of the Released Trademarks at Reel/Frame 6218/0101, (ii) Trademark Security Agreement, dated as of May 27, 2020, between Administrative Agent and Grantor, which was recorded in the United States Patent and Trademark Office on May 28, 2020, against certain of the Released Trademarks at Reel/Frame 6948/0223, and (iii) Trademark Security Agreement, dated as of July 10, 2020, between Administrative Agent and Grantor, which was recorded in the United States Patent and Trademark Office on August 12, 2020, against certain of the Released Trademarks at Reel/Frame 7020/0153, Grantor granted to Administrative Agent a continuing security interest (together with the security interest granted under the Security Agreement, the "Interest") in all of Grantor's right, title and interest in, to and under the Trademark Collateral, whether then existing or thereafter created or acquired, including the trademarks and trademarks applications shown on Exhibit "A" attached hereto (collectively, the "Released Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent does hereby (i) terminate, release and forever discharge its Interest in and to the Released Trademarks, (ii) terminate the Trademark

Security Agreements, and (iii) reassign to Grantor any right, title or interest of Administrative Agent in or to the Released Trademarks and all goodwill associated therewith. Administrative Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release. Delivery of an executed counterpart of a signature page of this Release by telecopy, emailed pdf. or any other electronic means that reproduces an image of the actual executed signature page shall be effective as delivery of a manually executed counterpart.
