RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on November 20, 2020, by East West Bank (the "Lender"), to Maui and Sons, which is the successor in interest to Harrow Street Limited (the "Grantor") for the trademarks listed on Schedule A hereto.

WHEREAS, the Lender and the Grantor were parties to a Trademark Security Agreement dated January 31, 2017 (the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Lender a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under the United States trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on March 20, 2017 at reel 006015/frame 0100;

WHEREAS, Grantor assigned all of its rights to the Trademarks to Maui and Sons on March 27, 2017, and said assignment was recorded in the United States Patent and Trademark Office on April 28, 2017 at reel 006045/frame 0298.

WHEREAS, the Lender wishes to release its security interest in the Trademarks and retransfer and reassign to Grantor's successor in interest Maui and Sons without recourse all of the Lender's right, title and interest in and to such Trademarks.

NOW, THEREFORE, the Lender hereby releases any security interest it may have in the Trademarks, and reassigns any and all right, title and interest it may have in and to such Trademarks without recourse to the Grantor's successor in interest Maui and Sons.

FURTHERMORE, the Lender hereby authorizes Maui and Sons and its authorized representatives or agents to record this Release of Trademark Security Interest with the United States Patent and Trademark Office.
