HEREBY AUTHORIZES AND REQUESTS the United States Patent and Trademark Office to record the Assignee as the owner of the Marks and the Registrations and to issue any and all registrations of the United States thereon to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives; and


