TERMINATION OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT (this "Termination") is made as of November 24, 2020 with reference to that certain Assignment for Security -- Trademarks (the "Trademark Security Agreement"), dated as of December 11, 2019, by FTD, LLC and Gateway Mercury Holdings, LLC (each, a "Grantor" and collectively, the "Grantors"), in favor of Cerberus Business Finance Agency, LLC, as collateral agent for itself and certain lenders (in such capacity, the "Collateral Agent").

WHEREAS, pursuant to the Trademark Security Agreement, Grantors granted to Collateral Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 16, 2019 at Reel/Frame 006816/0675.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Collateral Agent agrees as follows:

(a) Collateral Agent, without representation or warranty of any kind, hereby (i) releases, discharges, terminates and cancels all of its security interest and all other liens that it has in, to and under the Collateral and (ii) reassigns, grants and conveys to each Grantor all of Collateral Agent's right, title and interest in and to the Collateral, including the trademarks and service marks set forth on Schedule I attached hereto and all proceeds of the foregoing;

(b) Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement; and

(c) Collateral Agent agrees to take all further actions, and provide to Assignors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of all documents or other instruments), reasonably requested by Assignors, at Assignors' sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.

(d) Authorization to Record. The Collateral Agent authorizes and requests that this Termination be filed with the USPTO and any applicable government officer record this Termination.

(e) Governing Law. This Termination and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted with, the laws of the State of New York.
