**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”), effective as of this 25th day of November, 2020, is made by **TRUIST BANK**, as administrative agent (the “Administrative Agent”) for the holders of the Secured Obligations (as defined in the Security Agreement referred to below), in favor of **SWEETWATER BREWING COMPANY, LLC.**, a Georgia limited liability company (“Grantor”), as follows:

**W I T N E S S E T H**

WHEREAS, the Grantor and the Administrative Agent are party to that certain Security and Pledge Agreement, dated as of October 21, 2020 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), pursuant to which the Grantor granted to the Administrative Agent, among other Collateral as defined and set forth in the Security Agreement, a continuing security interest in, and a right to set off against, various assets of Grantor, including a continuing security interest in all right, title and interest of Grantor in and to the trademark registrations and trademark applications set forth on Schedule 1 attached hereto, including and all goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Notice of Grant of Security Interest in Trademarks, dated October 21, 2020 (as amended, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was duly recorded on October 21, 2020, at Reel/Frame 7085/0371 in the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Administrative Agent hereby terminates the Security Agreement and the Trademark Security Agreement and hereby terminates, cancels and releases any and all liens and security interests that it has in, to and under the Trademarks.
2. Authorization to Record. The Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.
3. Further Assurances. The Administrative Agent hereby agrees, at Grantor’s sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the intents and purposes of this Release.
4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the law of the State of New York.





