TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of November 16, 2012 by and among Multi Service Corporation, a Missouri corporation ("Assignor"), and MS Electronics LLC, a Kansas limited liability company ("Assignee").

WHEREAS, Assignor is the owner of the trademark registrations listed on Exhibit A attached hereto, and any and all statutory and common law rights therein (collectively, the "Marks").

WHEREAS, Assignor wishes to assign to Assignee all of Assignor's right, title and interest in and to the use of the Marks and all associated goodwill; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the Marks and all associated goodwill according to the terms of this Agreement;

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignees agree as follows:

1. For the consideration of \$10.00, Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title, and interest in and to the Marks, including all associated goodwill and all causes of action, past, present and future for infringement of the Marks subject to the covenants set forth below.
2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Marks in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the Marks or the history thereof as may be known to it.
3. Assignor agrees not to challenge or assist or cooperate with any third party challenging or taking any position contrary to or inconsistent with Assignee's sole and exclusive right in and to the Marks or the validity of the Marks.
4. This Agreement shall be governed by and construed in accordance with the laws of the State of Kansas without reference to choice of law rules. Any dispute arising under or in connection with this Agreement shall be resolved in the federal courts in and for Johnson County, Kansas, and the parties hereby submit to the exclusive jurisdiction of such courts in respect of any such proceeding.
