WHEREAS, Assignor is the owner of the trademark registration listed on Schedule A attached hereto ("Trademark"); and,


WHEREAS, Assignor wishes to assign all of its right, title and interest in and to the Trademark to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:



Assignor hereby covenants and agrees that the Assignor will at any time upon the request of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect said rights, titles and interests and said rights and privileges in Assignee, its successors, assigns and to permit Assignee and Assignee's successors and assigns to record this Agreement against the Trademark with any government office.

Assignor hereby constitutes and appoints Assignee and its successors and assigns as its true and lawful attorneys in fact in connection with the transactions contemplated by this Agreement, with full power of substitution to demand and receive, in the name and stead of Assignor but on behalf of and for the benefit of Assignee and its successors and assigns, the Trademark hereby conveyed, assigned, and transferred or intended so to be, and to give receipt and releases for and in respect of the same and any part therefor, and from time to time to institute and prosecute, in the name of Assignor or otherwise, for the benefit of Assignee or its successors and assigns, proceedings at law, in equity, or otherwise, which the Assignee or its successors or assigns deem proper in order to collect or reduce to possession or endorse the Trademark, and to do all acts and things in relation to the Trademark which Assignee or its successors or assigns reasonably deem desirable.
