**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), dated as of November 25, 2020, is executed by PACIFIC WESTERN BANK, a Delaware limited liability company ("Lender"), in favor of SHOPKEEP INC., a Delaware corporation ("Company"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Amended and Restated Intellectual Property Security Agreement, dated as of April 18, 2018 (the "Security Agreement"), by and between Company and Lender, Company granted to Lender a security interest in the Intellectual Property Collateral.

B. The Security Agreement was recorded with the (i) Patent Division of the United States Patent and Trademark Office at Reel/Frames 040231/0136, 041576/0625, 054048/0317 and 046914/0355 (as described in Exhibit A attached hereto), (ii) Trademark Division of the United States Patent and Trademark Office at Reel/Frames 5892/0152 and 6349/0442 (as described in Exhibit B attached hereto) and (iii) United States Copyright Office at Vol No. 9940 Doc. No. 970 (as described in Exhibit C attached hereto), in each case, to evidence the security interest granted under the Security Agreement.

C. Lender agrees to execute this Termination in order to evidence the termination and release of its security interest in the Intellectual Property Collateral.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby expressly terminates and releases all of Lender's right, title and interest in, to and under its Intellectual Property Collateral (including without limitation those Patents, Trademarks and Copyrights listed on Exhibits A, B and C attached hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.


