RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of November 18, 2020 ("Effective Date"), is made by Cerberus Business Finance, LLC, a Delaware limited liability company, as the Collateral Agent for itself and certain lenders ("Releasor"), in favor of CareGivers America, LLC, a Pennsylvania limited liability company ("Releasee").

WHEREAS, pursuant to that certain Pledge and Security Agreement dated February 9, 2016 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement") by and among the Releasee, Releasor, and others party thereto, Releasee assigned to the Releasor and granted to Releasor for the benefit of the Secured Parties a continuing security interest in all right, title and interest of the Releasee in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral");

WHEREAS, pursuant to that certain Assignment for Security -- Trademarks, dated February 9, 2016, recorded in the United States Patent and Trademark Office on February 11, 2016 at Reel 005728, Frame 0867 (the "Assignment for Security"), Releasee pledged, conveyed, sold, assigned, transferred and set over unto the Releasor and granted to Releasor for the benefit of the Releasor and the Secured Parties a continuing security interest in the Collateral, including the trademark registrations listed on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, Releasee has requested, and Releasor wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Assignment for Security.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Collateral, including without limitation, its continuing security interest in the Trademarks, and all goodwill of the business connected with the use of, and symbolized by, such Collateral, and hereby terminates the Security Agreement and the Assignment for Security.

IN WITNESS WHEREOF, the Releasor has caused this Release of Security Interest in Trademarks to be duly executed as of the Effective Date.
