Pursuant to Section 48-21-101 *et seq* of the Tennessee Business Corporation Act (the "TBCA"), the undersigned corporations hereby execute the following articles of merger:

FIRST: FB Financial Corporation, a Tennessee corporation, is the surviving corporation in the merger (the "Surviving Corporation").

SECOND: Franklin Financial Network, Inc., a Tennessee corporation and a wholly owned subsidiary of the Surviving Corporation, is the merging corporation in the merger (the "Merging Corporation").

THIRD: The Agreement and Plan of Merger, dated as of August 13, 2020 (the "Plan of Merger") by and between the Merging Corporation and the Surviving Corporation has been adopted and approved in accordance with the provisions of Sections 48-21-102 and 48-21-104 of the TBCA.

FOURTH: Pursuant to Section 48-21-105(c) of the TBCA, the shareholders of both the Surviving Corporation and the Merging Corporation are not required to approve the Plan of Merger.

FIFTH: These Articles of Merger shall become effective on August 15, 2020 at 12:02 a.m.


