**RELEASE AND TERMINATION OF SECOND LIEN SECURITY INTEREST IN
TRADEMARKS**

This RELEASE AND TERMINATION OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS is dated as of November 30, 2020 (the “**Release**”) and executed and delivered by JEFFERIES FINANCE LLC, as Collateral Agent (the “**Agent**”) in favor of PACKAGING COORDINATORS, LLC., a Delaware limited liability company, PACKAGING COORDINATORS, INC., a Delaware corporation, ANDERSONBRECON INC., an Illinois corporation and SHERPA CLINICAL PACKAGING, LLC, a California limited liability company (each, a “**Grantor**” and collectively, the “**Grantors**”). All capitalized terms used but not defined herein shall have the meaning given in the Trademark Security Agreements, as appropriate.

WHEREAS, certain of the Grantors and the Agent entered into that certain Second Lien Security Agreement dated as of July 1, 2016, to which SHERPA CLINICAL PACKAGING, LLC was joined as of October 1, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified, the “**Second Lien Security Agreement**”);

WHEREAS, pursuant to the Second Lien Security Agreement, the Grantors executed and delivered that certain Second Lien Trademark Security Agreement dated as of July 1, 2016 and a supplemental Trademark Security Agreement as of October 1, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified, each a “**Trademark Security Agreement**” and collectively the “**Trademark Security Agreements**”), whereby each Grantor granted to the Agent a security interest in and continuing lien upon the Trademark Collateral (as defined in the Trademark Security Agreements), including Trademarks set forth on Exhibit A attached hereto;

WHEREAS, the Second Lien Trademark Security Agreement dated July 1, 2016 was recorded with the United States Patent and Trademark Office on July 1, 2016 at Reel 005826 Frame 0234, and the supplemental Trademark Security Agreement dated October 1, 2018 was recorded with the United States Patent and Trademark Office on October 1, 2018 at Reel 006466 Frame 0169; and

WHEREAS, the obligations secured by the Trademark Security Agreements have been repaid or otherwise satisfied and the Agent therefore agrees to release any security interest the Agent may have in the Trademark Collateral pursuant to the Trademark Security Agreements, including any security interest in or to the Trademarks identified in Exhibit A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

SECTION 1. Release of Security Interest. The Agent does hereby, without recourse, representation or warranty of any kind, (i) terminate and cancel the Trademark Security Agreements and (ii) release, terminate and discharge all of the Agent’s security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral granted pursuant to the

Trademark Security Agreements, including the Trademarks identified in Exhibit A attached hereto.

SECTION 2. Recordation. The Agent authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable government official of any applicable governmental authority record this Release at the Grantors' sole cost and expense.

SECTION 3. Further Assurances. The Agent agrees to execute and deliver to the Grantors any further documents and to do such other acts that the Grantors reasonably request in order to confirm, effectuate or record this Release at the Grantors' sole cost and expense.

SECTION 4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER AND ALL CLAIMS AND CONTROVERSIES ARISING OUT OF THE SUBJECT MATTER HEREOF WHETHER SOUNDING IN CONTRACT LAW, TORT LAW OR OTHERWISE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PROVISIONS THAT WOULD RESULT IN THE APPLICATION OF ANY OTHER LAW (OTHER THAN ANY MANDATORY PROVISIONS OF LAW RELATING TO THE LAW GOVERNING PERFECTION AND THE EFFECT OF PERFECTION OF THE SECURITY INTEREST).


