

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated November 30, 2020 by BMO Harris Bank N.A., a national banking association ("*BMO*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Lenders as defined in the Credit Agreement as defined in the Agreement (BMO acting as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


