TRADEMARK ASSIGNMENT AGREEMENT

Assignor hereby conveys, transfers and assigns to Assignee, all right, title and interest in and to the Assigned Marks, together with any registrations for the Assigned Marks worldwide; the goodwill of the business symbolized by the Assigned Marks; and all rights of action accrued, accruing and to accrue under and by virtue hereof, including the right to sue or otherwise recover for past infringement and receive all damages, payments, costs and fees associated therewith.
2. Assignor further grants, conveys and assigns to Assignee all its right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past and future infringement of any of the Assigned Marks.
3. Assignor represents and warrants that it has not executed, and will not execute, any agreement in conflict herewith.
4. Assignor hereby agrees to execute all such documents as may be required to transfer and, when applicable, to record the transfer of the Assigned Marks.


