**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of November 30, 2020 by **GOLDMAN SACHS LENDING PARTNERS LLC**, in its capacity as Collateral Agent, in favor of **CLOUD PACKAGING SOLUTION LLC**, a Delaware limited liability company (the "*Grantor*"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Grants (as defined below).

**WHEREAS**, pursuant to that certain Security Agreement, dated as of May 23, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), among the Grantor, the other grantors (including Ryt-way Industries, LLC) party thereto and the Collateral Agent, the Grantor executed and delivered a Trademark Security Agreement, dated as of May 23, 2018, granting the Collateral Agent a security interest in and lien on certain Trademarks and Trademark applications defined and described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on June 7, 2018 at Reel 6347, Frame 0382 (such Trademark Security Agreement, as amended, restated, supplemented or otherwise modified prior to the date hereof, "*Grant 1*");

**WHEREAS**, pursuant to the Security Agreement, Ryt-way Industries, LLC executed and delivered a separate Trademark Security Agreement, dated as of May 23, 2018, granting the Collateral Agent a security interest in and lien on Trademark Reg. No. 4,158,427 for HYDROFORMA (the "*Additional Mark*"), which was recorded with the USPTO on May 31, 2018 at Reel 6339, Frame 0911 (such separate Trademark Security Agreement, solely as it relates to the Additional Mark, "*Grant 2*", and collectively with Grant 1, the "*Grants*");

**WHEREAS**, subsequent to the Security Agreement, on June 5, 2018, Ryt-way Industries, LLC assigned to Grantor all of its right, title and interest in the Additional Mark, which assignment was recorded with the USPTO on June 6, 2018 at Reel 6347, Frame 0435;

**WHEREAS**, the Grantor requested that the Collateral Agent terminate the Grants, and release and discharge its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral defined and described in the Grants.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby:

1. terminates the Grants and releases and discharges its security interests in and liens on all right, title and interest of the Grantor in, to and under, and reassigns to the Grantor, all of the Trademark Collateral, including those Trademarks and Trademark applications identified in Schedule 1 hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
