- B. The Assignor has agreed to assign the Trade Marks to the Assignee for the consideration hereinafter appearing.

- 1) In pursuance of the said Agreement and in consideration of the sum of five hundred British pound (£500) now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged by the Assignor), the Assignor hereby assigns with full title guarantee unto the Assignee, the Trade Marks and all right, title and interest therein together with the goodwill symbolised in the Trade Marks unto the Assignee absolutely.
- 2) The Assignor covenants to execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be required by the Registrar of Trade Marks for absolutely vesting the benefit of the Trade Marks in favour of the Assignee.




