WHEREAS, the Assignor and Assignee are both duly authorized and capable of entering into this Confirmatory Assignment.


NOW, THEREFORE, for valuable consideration, the receipt of which is acknowledged, the parties hereto agree as follows:

IN WITNESS whereof, the Assignor and Assignee have executed this Confirmatory Assignment as of the dates set forth below.


