RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS (this "**Release**") is made and effective as of November 30, 2020 (the "**Effective Date**") and granted by FIFTH THIRD BANK, an Ohio banking corporation ("**Fifth Third**"), as Administrative Agent (in such capacity, "**Agent**") for the ratable benefit of the Secured Parties (defined below), in favor of ECHOSAT, INC., a Delaware corporation ("**EchoSat**") and CONTROLSCAN, INC., a Delaware corporation ("**ControlScan**"; EchoSat and ControlScan, each a "**Debtor**" and collectively, "**Debtors**"); and has reference to the following facts and circumstances (the "**Recitals**"):

A. Debtors, LC Issuer (as therein defined), Lenders (as therein defined) executed the Amended and Restated Loan Agreement dated as of the July 28, 2017, as subsequently amended (the "**Loan Agreement**") and Debtors and Agent (for the ratable benefit; all capitalized terms used and not otherwise defined in this Agreement shall have the respective meanings ascribed to them in the Loan Agreement).

B. As described in the Amended and Restated Patent, Trademark and License Security Agreement dated as of July 28, 2017, executed by each Debtor in favor of Agent, as amended (the "**Security Agreement**"), each Debtor granted to Agent, for the ratable benefit of Lenders, a security interest in and lien on, all of such Debtor's right, title and interest in, to and under the IP Collateral (as defined below). The Security Agreement was recorded with the United States Patent and Trademark Office on February 22, 2016, at Reel/Frame 005736/0463.

C. Debtors requested that Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to Debtors of any and all right, title and interest Agent and Lenders may have in the IP Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Agent states as follows:

1. **Recitals.** The Recitals are true and correct, and, together with the defined terms set forth herein, are incorporated by this reference.

2. **Release of Security Interest.** Agent terminates the Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreement in any and all right, title and interest of Debtors and reassigns to Debtors any and all right, title and interest that it may have, in, to and under the IP Collateral, including certain trademarks, trademark applications, domain names and licenses described in Exhibit A. "**IP Collateral**" shall mean (i) Patents (as defined in the Security Agreement), (ii) Trademarks (as defined in the Security Agreement), (iii) Licenses (as defined in the Security Agreement), (iv) the goodwill of such Debtor's business connected with and symbolized by the Trademarks; and (v) all proceeds, including, without limitation, proceeds which constitute property of the types described in (i)-(iv) above and any rents and profits of any of the foregoing items, whether cash or noncash, immediate or remote, and insurance proceeds, and all products of (i)-(iv) above, and any indemnities, warranties, and guaranties payable by reason of loss or damage to or otherwise with respect to any of the foregoing items.

3. **Further Assurances.** Agent agrees, at Debtors' expense, to take all further actions, and provide to Debtors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as Debtors and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

4. **Governing Law.** The validity and interpretation of this Release and the rights and obligations of Agent shall be governed by and construed in accordance with the substantive laws of the State of Missouri (without reference to conflict of law principles).

Agent executed this Release in favor of Debtors as of the Effective Date.


