**TRADEMARK ASSIGNMENT AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys unto Assignee all of its rights, title and interest in and to the Mark, whether statutory or at common law, including the Registration, together with the goodwill of the business symbolized by the Mark, and the Registration, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof.

Assignor represents and warrants that it has the full power and authority to execute this Assignment and that this Assignment is binding upon the parties and enforceable in accordance with the Assignment's terms.

This Assignment may be executed in multiple counterparts, and by facsimile or electronic signatures, including, without limitation, scanned signature pages, each of which shall be deemed an original but all of which together shall constitute one and the same Assignment.

The undersigned individuals hereby warrant and represent that they have full authority to execute this Assignment on behalf of the party for which they signed.


