

INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment Agreement") is made as of December 4th, 2020 by New West Oil Company, L.L.C., an Arizona limited liability company, New West Environmental LLC, an Arizona limited liability company (each, an "Assignor"), and collectively, the "Assignors"), in favor of RelaDyne West, LLC, a Delaware limited liability company ("Assignee").

Assignors hereby absolutely, irrevocably and unconditionally convey, assign, transfer and agree to assign and deliver to Assignee and its successors and assigns forever, without any restrictions, limitations or reservations, all of Assignors' right, title and interest in and to the Assigned IP together with the goodwill of the business connected with the use of, and symbolized by, the Assigned IP, as fully and entirely as the same would have been held and enjoyed by Assignors had this IP Assignment Agreement not been made, including the following:
 - (a) all (i) trademark applications and registrations set forth on Exhibit A, and (ii) trademarks underlying the trademark applications and registrations set forth on Exhibit A;
 - (b) all unregistered trademarks, services marks and trade names set forth on Exhibit A;
 - (c) all unregistered copyrights and works of authorship set forth on Exhibit A;
 - (d) any and all rights of any kind whatsoever of Assignors accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
 - (e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
 - (f) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the

right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

- 2. Recordation and Further Actions. Assignors hereby authorize the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment Agreement upon request by Assignee. Following the date hereof, Assignors shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Assigned IP to Assignee, or any assignee or successor thereto.
- 3. <u>Assignment</u>. This IP Assignment Agreement shall be binding upon and inure to the benefit of the parties to this IP Assignment Agreement and their successors and assigns.
- 4. <u>Counterparts</u>. This IP Assignment Agreement may be executed in multiple counterparts, all of which shall be considered one and the same agreement and shall become effective when one or more counterparts have been signed by each of the parties delivered to the other party, it being understood that all parties need not sign the same counterpart.
