CONFIRMATION OF TRADEMARK ASSIGNMENT

Perspica has assigned and transferred, and CSI has received and accepted, all of Perspica's rights, title and interest throughout the world in and to the Perspica Marks and all the rights, claims and privileges pertaining to the Perspica Marks, including without limitation: the registrations pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Perspica Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Perspica in all matters related thereto.


Perspica hereby authorizes and requests that the relevant officials of the relevant countries implement this Assignment.
