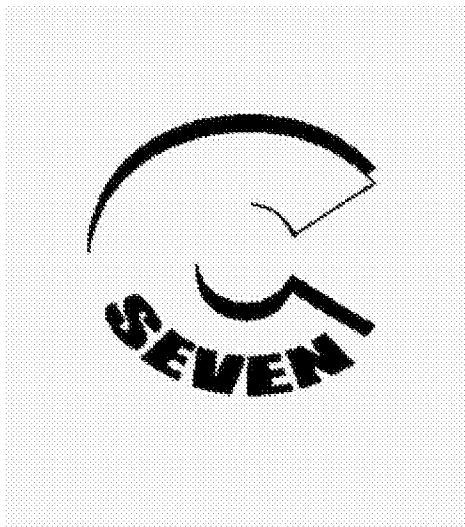

5. The Price is payable in U.S. dollars and is payable as follows: on the signing of this Agreement.


Representations and Warranties


