**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, together with the goodwill of the business symbolized by the TRADEMARK, ASSIGNOR does hereby assign, grant, transfer and otherwise convey to ASSIGNEE, its successors, and assigns, its entire right, title and interest in and to the TRADEMARK, including but not limited to all of ASSIGNOR'S common law rights and registrations pertaining thereto, all rights to sue for past, present or future infringement, misappropriation, unfair competition, or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, as well as all of the goodwill of the business symbolized by the TRADEMARK.

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States, as well as any official of any countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARK and title thereto as the property of ASSIGNEE, its successors and assigns, in accordance with the terms of this Agreement.
