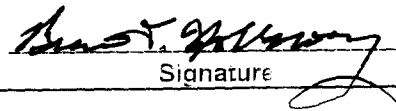

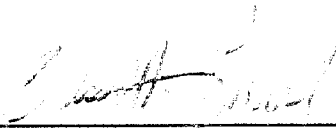

PHASECOM, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That by Action By Unanimous Written Consent of the Board of Directors of PhaseCom, Inc., resolutions were duly adopted setting forth a proposed amendment of the Second Amended and Restated Certificate of Incorporation of said corporation, declaring said amendment to be advisable and directing that approval of said amendment be obtained from holders of a majority of the issued and outstanding Common Stock, Series A Convertible Preferred Stock, Series B Convertible Preferred Stock and Series C Convertible Preferred Stock of said corporation entitled to vote, collectively voting as a single class. The resolutions setting forth the proposed amendment are as follows:
