ACQUIRED INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Acquired Intellectual Property Assignment Agreement (this “Agreement”) dated as of October 20, 2020 (the “Effective Date”) is entered into by and among Remington Arms Company, LLC (“Assignor”), and Sportsman’s Warehouse, Inc., a Utah corporation (“Recipient”).

Assignor and Recipient have entered into that certain Asset Purchase Agreement dated as of October 7, 2020, by and among Remington Outdoor Company, Inc., FGI Operating Company, LLC, FGI Holding Company, LLC, Barnes Bullets, LLC, RA Brands, L.L.C., FGI Finance Inc., Huntsville Holdings LLC, TMRI, Inc., Remington Arms Distribution Company, LLC, 32E Productions, LLC, Great Outdoors Holdco, LLC, Outdoor Services, LLC, Assignor and Recipient (the “Purchase Agreement”). Capitalized terms used and not defined herein have the meanings ascribed to them in the Purchase Agreement.

Assignor wishes to assign, transfer, and convey to Recipient all of Assignor’s right, title, and interest in and to the Acquired Intellectual Property, including, without limitation, those Intellectual Property Rights described on Schedule 1 attached hereto.

Assignor and Recipient agree as follows:

1. Assignment. Assignor hereby irrevocably assigns, transfers, and conveys to Recipient all of Assignor’s right, title, interest and goodwill in and to the Acquired Intellectual Property, including, without limitation, those Intellectual Property Rights described on Schedule 1 attached hereto. The foregoing assignment includes all claims, actions, rights, and demands to the extent arising from the Acquired Intellectual Property, including, without limitation, causes of action to sue for past, current, or future infringement, dilution, misappropriation, or violation thereof and other enforcement rights, including, without limitation, the right to collect and retain all proceeds and damages therefrom.


2. General. This Agreement shall be subject to Article 11 of the Purchase Agreement, which is hereby incorporated by reference herein, mutatis mutandis.


