GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, **AWARENESS TECHNOLOGIES, INC.**, a Delaware corporation, and **VERIATO, INC.**, a Delaware corporation (each, a “*Grantor*”, and collectively, the “*Grantors*”), and **WEBSTER BANK, NATIONAL ASSOCIATION** (the “*Administrative Agent*”) are parties to a Security Agreement, dated as of December 3, 2020 (as amended, supplemented or otherwise modified from time to time, the “*Security Agreement*”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

Pursuant to the Security Agreement, the Grantors have granted to the Administrative Agent a security interest in and to the Collateral, including, without limitation, certain of its intellectual property.

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, each Grantor does hereby further grant to the Administrative Agent a security interest in and to the following property of such Grantor, now owned or hereafter acquired by such Grantor (collectively, the “*Trademark Collateral*”), to secure the prompt payment, performance and observance of the Obligations (as such term is defined in the Credit Agreement referred to in the Security Agreement):

- (a) trademarks and registrations thereof, including the trademarks listed on Schedule 1 attached hereto (collectively, the “*Trademarks*”);
- (b) the goodwill of the business symbolized by the Trademarks; and
- (c) all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof.


Notwithstanding the foregoing, for clarity, the Trademark Collateral does not include any intent-to-use trademark applications to the extent that, and solely during the period in which, the grant, attachment or enforcement of a security interest therein would impair the validity or enforceability of, or render void or result in the cancellation of, such application or any registration issued as a result of such intent-to-use trademark applications under applicable Law.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


