**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of December 11, 2020 by **SILICON VALLEY BANK**, a California corporation, with a loan production office located at 3003 Tasman Drive, HF 150, Santa Clara, California 95054 (the “*Bank*”), in favor of **MEDICAL ADVOCACY SERVICES FOR HEALTHCARE, INC.**, a Texas corporation, whose address is 518 South Magnolia Avenue, Third Floor, Orlando, Florida 32801 (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of August 2, 2016, (as may be amended, modified, restated, replaced, or supplemented from time to time, the “*Agreement*”), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademark and Trademark Applications (“*Trademarks*”), notice of which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on August 8, 2016, at Reel 005848, Frame 0726.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in the Agreement) as herein provided; and


WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including, without limitation, those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
