## CONFESSION OF JUDGMENT

This Confession of Judgment is freely and voluntarily executed and entered into by Herrmann International, Inc. ("HI") and Herrmann Global, LLC ("HG"), residents of Rutherford County, North Carolina, in favor of Altera Law Group, LLC and Hamre Schumann, Mueller and Larson, PA (Altera- HSML) , a resident of Hennepin County, Minnesota, and is intended to constitute a lawful confession of judgment pursuant to either Minn. Stat. § 548.22 or N.C. Stat. § 1A-1, Rule 68.1. or equivalent statutes in other states including Washington, where Michael Lasky, member of Altera is resident.

### RECITALS

1. HI and HG acknowledge that that they are jointly indebted to Altera-HSML ("Altera-HSML ") in the amount of \$129,602. The concise facts from which HI's and HG's debt to Altera-HSML: On 4 Aug 2005, HI and HG signed a representation agreement ("the Agreement") with Altera to provide legal services in the field of intellectual property.




