**TRADEMARK SECURITY AGREEMENT**

This Trademark Security Agreement is made as of December 9, 2020 (this “Agreement”), by and among **NUTRISYSTEM, INC**, a Delaware corporation (“Nutrisystem”), **SBD ENTERPRISES, LLC**, a Delaware limited liability company (“SBD Enterprises”; and together with Nutrisystem, collectively, the “Grantors” and each individually, a “Grantor”), and **COÖPERATIVE RABOBANK U.A., NEW YORK BRANCH**, in its capacity as Administrative Agent for the Lender Parties (together with its successors and assigns in such capacity, “Grantee”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge and Security Agreement (defined below).

WHEREAS, the Grantors, Grantee, and the other parties thereto have entered into a Pledge and Security Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Pledge and Security Agreement”), pursuant to which each Grantor has granted Grantee a security interest in the Collateral for the benefit of the Lender Parties; and

WHEREAS, each Grantor is the owner of the trademark registrations and applications for trademark registrations listed on the attached Schedule A (the “Trademarks”); and

WHEREAS, the Grantors and Grantee wish to enter this Agreement in conjunction with the security interest in the Collateral granted by each Grantor to Grantee for the benefit of the Lender Parties under the Pledge and Security Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors and Grantee hereby agree that:

1. Each Grantor hereby pledges and grants to Grantee for the benefit of the Lender Parties a continuing security interest in all of such Grantor’s right, title and interest in and to (a) the Trademarks, (b) all extensions, modifications and renewals thereof, (c) all Goodwill of such Grantor's business symbolized by the foregoing or associated therewith, and (d) all of such Grantor's rights corresponding thereto throughout the world (collectively, the “Trademark Collateral”) solely for the purpose of securing the Grantors’ payment, performance and observance of the Secured Obligations pursuant to and under the Pledge and Security Agreement. This Agreement is not to be construed as an assignment of any Trademark or Trademark application. Notwithstanding the foregoing, no grant of any Lien or security interest shall be deemed granted hereunder on or in any “intent to use” application for trademark registration filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. Section 1051, for which a Statement of Use or Amendment to Allege Use, as applicable, has not been filed and accepted, solely to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent to use application under applicable federal law.

2. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral (including the Trademark) are more fully set forth in the Pledge and Security Agreement, the terms and provisions of which are hereby incorporated herein

by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Pledge and Security Agreement, the terms of the Pledge and Security Agreement shall control.

3. Upon the Payment in Full of the Secured Obligations (other than indemnity obligations under the Loan Documents that are not then due and payable or for which any events or claims that would give rise thereto are not pending), Grantee shall promptly execute, acknowledge and deliver to the applicable Grantor an instrument in writing in recordable form and reasonably acceptable to such Grantor releasing the security interest in the Trademarks granted under this Agreement.



This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart by facsimile or electronic mail shall be equally effective as delivery of an original executed counterpart.

5. This Agreement shall be construed in accordance with and governed by the laws of the State of New York.


