For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by both Parties, Assignor does hereby assign to Assignee and its successors, assigns and legal representatives, the full and exclusive right, title, and interest in and to the Marks and the registrations thereof in the United States of America and all jurisdictions throughout the world, including all countries and political entities, together with all of the goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks, along with the right to recover for damages and profits for past infringements thereof.

Assignor covenants it has the full right and power to convey the entire interest herein assigned, and that it has not executed and shall not hereafter execute any document in conflict with this Assignment. Assignor further covenants it will at any time and at the request of Assignee execute such documents and take such other action that, in the sole opinion of Assignee, may be desirable or necessary to secure to Assignee, its successors, legal representatives and assigns, all rights conveyed and intended to be conveyed by this Assignment.
