## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 28, 2020 (“Release”), is made by Deutsche Bank Trust Company Americas, a New York banking corporation, as collateral agent (in such capacity, together with its successors and assigns in such capacity, the “Collateral Agent”) in favor of Arhaus, LLC, a Delaware limited liability company (the “Grantor”).

**WHEREAS**, pursuant to that certain Guaranty and Collateral Agreement dated as of June 26, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Guaranty and Collateral Agreement”) by and among the Grantor, the other parties party thereto and the Collateral Agent, and the Second Lien Intellectual Property Security Agreement dated as of June 26, 2017 by and among the Grantor, the other parties party thereto and Collateral Agent (the “IP Security Agreement”), the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a continuing security interest in any and all right, title and interest of the Grantor in and to the Intellectual Property Collateral; and

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on June 30, 2017 at Reel 6096 Frame 0392.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of the Secured Parties, and the Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Guaranty and Collateral Agreement or the IP Security Agreement, as applicable.

**SECTION 2. Termination and Release.** The Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

- (a) terminates, cancels, discharges, and releases the continuing security interest in, and any and all right, title and interest of the Collateral Agent in and to the Intellectual Property Collateral listed on Schedule A attached hereto;
- (b) reassigns, grants and conveys to the Grantor any and all of the Collateral Agent’s right, title and interest in and to the Intellectual Property Collateral listed on Schedule A attached hereto; and
- (c) authorizes the recordation of this Release with the USPTO at the Grantor’s sole cost and expense.

**SECTION 3. Further Actions.** The Collateral Agent agrees to take all further actions, and provide to the Grantor and its respective successors, assigns or representatives, all such cooperation and assistance reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

**SECTION 4. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.


**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
