TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (as amended, restated, supplemented or otherwise modified from time to time, this “**Trademark Security Agreement**”) dated as of December 11, 2020, is between GINDI C21 IP LLC, a Delaware limited liability company (the “**Grantor**”) and ALX C21 LLC, a Delaware limited liability company, located at 888 Seventh Avenue, New York, New York 10019 (the “**Secured Party**”).

For good and valuable consideration, and to grant security in connection with the Grantor’s obligations in paragraphs 17 and 18 of that certain Amended and Restated Operating Agreement of Gindi C21 IP LLC dated November 30, 2020, the receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

Grantor hereby grants to the Secured Party, a security interest in all of Grantor’s right, title and interest in and to the following (the “**Collateral**”):

- (i) the trademark and service mark registrations and applications set forth in Schedule A hereto, together with the goodwill of the business connected with the use thereof and symbolized thereby;
- (ii) all renewals of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of Grantor accruing thereunder or pertaining thereto;
- (iii) any and all claims for damages, other payments and/or injunctive relief for past, present and future infringement, dilution, or violation with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages, payments or other relief; and
- (iv) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and/or payable with respect to, and supporting obligations relating to, any and all of the foregoing or arising from any of the foregoing.

Grantor authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Trademark Security Agreement.


