**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this “**Release**”), dated as of December 11, 2020, is made by **ANTARES CAPITAL LP** (as successor in interest to General Electric Capital Corporation pursuant to that certain Assignment of Intellectual Property Agreement dated as of August 21, 2015), as administrative agent (the “**Agent**”), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement dated as of March 30, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Credit Agreement**”), among Bendon, Inc., a Delaware corporation (the “**Borrower**”), the other Credit Parties, the Lenders and the L/C Issuers from time to time party thereto, and the Agent, and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith or in connection with prior versions thereof, the Lenders made loans and other financial accommodations to the Borrower;

**WHEREAS**, in connection with that certain Guaranty and Security Agreement dated as of March 30, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Guaranty and Security Agreement**”), among the Agent and the Grantors party thereto, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the “**Security Agreements**”), the Borrower and Dalmatian Press, LLC, a Tennessee limited liability company, as the grantors (collectively, the “**Grantors**”) granted security interests in certain intellectual property owned by them including those listed on Annex I attached hereto (collectively, the “**Intellectual Property Collateral**”); and

**WHEREAS**, the Security Agreements were recorded in the United States Patent and Trademark Office or the United States Copyright Office, as applicable, on the dates and on the reels/frames or volumes/documents, as applicable, set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its right, title and interest in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, including the intellectual property registrations and applications set forth on Annex I attached hereto, together with any goodwill related thereto, granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement or the Guaranty and Security Agreement, and the Agent hereby reassigns to the Borrower any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement or the Guaranty and Security Agreement.

The Agent authorizes the Borrower and the Grantors (or their respective designees), at the Borrower’s expense, to file this Release with the United States Patent and Trademark Office and the United States Copyright Office.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


