Release of Security Interests in Intellectual Property Rights

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY RIGHTS (this “**Release**”) is made and entered into as of December 16, 2020, by Credit Suisse AG, Cayman Islands Branch, a Switzerland bank located at Eleven Madison Avenue, New York, New York 10010, as Administrative Agent and Collateral Agent for the Secured Parties (in such capacities and together with its successors and permitted assigns, the “**Administrative Agent**”) in favor of Ciox Health, LLC (f/k/a HealthPort Technologies, LLC, successor-by-merger to IOD Incorporated), a Georgia limited liability company located at 925 North Point Parkway, Suite 350, Alpharetta, Georgia 30005.

WHEREAS, Care Communications, Inc. is a party to that certain Security Agreement Supplement, dated as of September 21, 2015, by Care Communications, Inc. in favor of the Administrative Agent, which supplemented that certain Security Agreement, dated as of December 1, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) among the grantors party thereto and the Administrative Agent;

WHEREAS, pursuant to the Security Agreement, Care Communications, Inc. entered into that certain: (i) Trademark Security Agreement, dated as of September 21, 2015, in favor of the Administrative Agent (the “**Trademark Security Agreement**”) and recorded with the United States Patent and Trademark Office on September 21, 2015 at Reel/Frame 5626/0905 and (ii) Copyright Security Agreement, dated September 21, 2015, in favor of the Administrative Agent (together with the Trademark Security Agreement, the “**IP Security Agreements**”) and recorded with the United States Copyright Office on September 22, 2015 at Volume/Document V9927 D418;

WHEREAS, pursuant to the IP Security Agreements, Care Communications, Inc. pledged and granted to Administrative Agent, as security for the payment and performance in full of the Secured Obligations of Care Communications, Inc., a security interest in all right, title or interest in or to any and all of the Trademark Collateral and Copyright Collateral (as such terms are defined in the IP Security Agreements) then owned or at any time thereafter acquired by Care Communications, Inc. or in which Care Communications, Inc. then had or at any time in the future acquired any right, title or interest; and

WHEREAS, the Secured Obligations have been paid in full, and as a result, the Administrative Agent has agreed to terminate and release all security interests held by the Administrative Agent as security for the Secured Obligations under the Security Agreement and IP Security Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

Section 1. Defined Terms. Capitalized terms used in this Release and not otherwise defined herein shall have the meanings specified in the Security Agreement or IP Security Agreements, as applicable.

Section 2. Release of Security Interest. The Administrative Agent hereby terminates, releases and fully discharges any and all security interest it has under the Security Agreement and IP Security Agreements in any right, title and interest in, to or under the Trademark Collateral and Copyright Collateral, including, without limitation, the registrations and applications set forth on Schedule I hereto.

Section 3. Recordation of Release. The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office and United States Copyright Office record this Release.


Section 4. Governing Law. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.



The term "**Electronic Signature**" means an electronic sound, symbol, or process attached to, or associated with, a contract or other record and adopted by any natural person, corporation, limited liability company, trust, joint venture, association, company, partnership, governmental authority or other entity with the intent to sign, authenticate or accept such contract or record.


