## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (“**Release**”) is made and effective as of November 12, 2020 and granted by Petrus Agent, LLC (“**Petrus**”), a Delaware limited liability company, as administrative agent for the secured parties under the Collateral Agreement referred to below (the “**Secured Parties**”), in favor of Cricut Holdings, LLC (f/k/a Provo Craft Holdings, LLC), a Delaware limited liability company and Cricut, Inc. (f/k/a Provo Craft & Novelty, Inc.), a Delaware corporation (collectively, the “**Grantors**”) and their successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Collateral Agreement by and among the Grantors and Petrus dated as of September 20, 2013 (the “**Collateral Agreement**”);

WHEREAS, pursuant to the Collateral Agreement, each Grantor pledged and granted to Petrus for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the IP Collateral (as defined below);

WHEREAS, the Notice of Grant of Security Interest in Patents was recorded with the United States Patent and Trademark Office at Reel 031345, Frame 0050 on October 4, 2013, as amended by Reel 032312, Frame 0209 on February 21, 2014, and Reel 031345, Frame 0022 on October 4, 2013;

WHEREAS, the Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office at Reel 5124, Frame 0366 on October 3, 2013 and Reel 5128, Frame 0355 on October 3, 2013; and

WHEREAS, the Grantors have requested that Petrus enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantors of any and all right, title and interest Petrus and the Secured Parties may have in the IP Collateral pursuant to the Collateral Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Petrus hereby states as follows:

1. Release of Security Interest. Petrus, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Collateral Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Collateral Agreement in any and all right, title and interest of the Grantors, and reassigns to the Grantors any and all right, title and interest that it may have, in, to and under the following (collectively, the “**IP Collateral**”):

(a) any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent applications listed in Schedule 1 hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the “**Patents**”);

(b) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (“**Trademarks**”);

(c) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and


(e) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York any other jurisdiction).
