CERTIFICATE OF MERGER

OF

INSTITUTE FOR SUPPLY MANAGEMENT, INC.
(a New York Not-for-Profit Corporation)

INTO

INSTITUTE FOR SUPPLY MANAGEMENT AZ, INC.
(an Arizona Nonprofit Corporation)

(Under Section 906 of the New York Not-For-Profit Corporation Law)

It is hereby certified, on behalf of each of the constituent corporations herein named, as follows:

First: The names of the constituent corporations are: INSTITUTE FOR SUPPLY MANAGEMENT AZ, INC., a corporation organized under the Arizona Nonprofit Corporation Act (the "ANCA"), which was originally incorporated on January 2, 2020 (the "Surviving Corporation" or "ISM-AZ"), and INSTITUTE FOR SUPPLY MANAGEMENT, INC., a corporation organized under the New York Membership Corporations Law, which was originally incorporated under the name NATIONAL ASSOCIATION OF PURCHASING AGENTS, INC. on March 10, 1965 (the "Disappearing Corporation" or "ISM-NY"). For avoidance of doubt ISM-NY, the Disappearing Corporation, is merging with and into ISM-AZ, the Surviving Corporation. The effective date of the Merger is September 1, 2020 (the "Effective Date").

Second: The name of the Surviving Corporation is "*Institute for Supply Management AZ, Inc.*"

Third: As to each constituent corporation, the Agreement and Plan of Merger, dated as of August 12, 2020, made and entered into by ISM-AZ and ISM-NY (the "Plan") and the merger provided thereunder (the "Merger") sets forth a description of the membership and management of each constituent corporation as follows:

ISM-AZ – the members of ISM-AZ are the Incorporators of ISM-AZ as described in the ISM-AZ bylaws; no holders of any certificates evidencing capital contributions or subventions; there is one class of members with full voting rights and each member has one vote on all matters that require a vote of the members.

ISM-NY – approximately 37,290 members; no holders of any certificates evidencing capital contributions or subventions; there is one class of members with full voting rights and each member is entitled to cast one (1) vote on all matters which require a vote of the members.

Fourth: The Certificate of Incorporation of the Disappearing Corporation was filed and recorded with the New York Department of State on March 10, 1965.

The Articles of Incorporation of the Surviving Corporation were filed and recorded with the Arizona Corporation Commission on January 2, 2020.

Fifth: No Application for Authority of ISM-AZ to transact business in New York was filed, and ISM-AZ will not conduct activities in New York until such Application for Authority is filed.

Sixth: The Surviving Corporation authorized the Merger by the approval of the Plan by a Joint Action by Unanimous Written Consent of the Board of Directors and Members on January 2, 2020.

Seventh: The Merger was authorized with respect to ISM-NY in the following manner: The Plan was adopted by the Board of Directors of ISM-NY at a duly called and held meeting on April 26, 2020, by vote of a majority of the Directors present at the time of the vote, a quorum being present at that time. The Board of Directors of ISM-NY submitted the Plan to a vote of the members. Notice of meeting was given to each member. A copy of the Plan and an outline of the material features of the Plan accompanied the notice. The Plan was approved at a duly called and held meeting of the members on August 12, 2020, by two-thirds of the votes cast at the meeting, the affirmative votes cast in favor of the Plan being at least equal to the quorum, blank votes and abstentions not being counted in the number of votes cast.

Eighth: The Surviving Corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of the Disappearing Corporation, previously amenable to suit in the State of New York, and the Surviving Corporation may be sued in the State of New York in respect of any property transferred or conveyed to it as provided under the New York Not-for-Profit Corporation Law.

Ninth: The Surviving Corporation hereby designates the Secretary of State of the State of New York as its agent upon whom process against it may be served in the manner set forth in paragraph (b) of Section 306 of the New York Not-For-Profit Corporation Law in any action or special proceeding described in paragraph (D) of Section 906 of the New York Not-For-Profit Corporation Law. The post office address in the State of Arizona to which the Secretary of State shall mail a copy of any process against the Surviving Corporation served upon him is: 309 West Elliot Road, Suite 113, Tempe, AZ 85284, Attn: Chief Executive Officer.

Tenth: The Merger is permitted by the laws of the State of Arizona, the jurisdiction of ISM-AZ, and is in compliance therewith.


