

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
INSTITUTE FOR SUPPLY MANAGEMENT AZ, INC.**

Pursuant to A.R.S. Section 10-11006, the Articles of Incorporation of Institute for Supply Management AZ, Inc. are hereby amended as follows:

- FIRST:** The name of the Arizona nonprofit corporation (the "Corporation") is: **Institute for Supply Management AZ, Inc.**
- SECOND:** The Articles of Incorporation for the Corporation were filed with the Arizona Corporation Commission on January 2, 2020, under File Number 23049200.
- THIRD:** ARTICLE I of the Corporation's Articles of Incorporation is hereby deleted in its entirety and replaced by the following:
- "NAME.** The name of this Arizona nonprofit corporation is **Institute for Supply Management, Inc. (the "Corporation")."**
- FOURTH:** Except as expressly set forth herein, the Articles of Incorporation of the Company remain in effect as originally filed.
