TRADEMARK ASSIGNMENT

This Trademark Assignment ("**Assignment**"), effective as of October 1, 2020 ("**Effective Date**"), is made by **1,000 Days**, a District of Columbia nonprofit corporation and Internal Revenue Code Section 501(c)(3) tax exempt organization ("**1,000 Days**"), in favor of **FHI Solutions LLC**, a North Carolina limited liability company, the single member of which is an Internal Revenue Code Section 501(c)(3) tax exempt organization ("**FHI Solutions**").

1,000 Days is the sole and exclusive owner of all right, title, and interest in and to the trademarks and the corresponding registrations set forth on Exhibit 1 (collectively, the "**Assigned Trademarks**"), together with the goodwill of the Activities connected with and symbolized by the Assigned Trademarks.

1,000 Days and FHI Solutions have entered into an Asset Transfer Agreement, dated as of October 1, 2020 (the "**Transfer Agreement**"), pursuant to which, among other things, 1,000 Days has agreed to assign all of its right, title, and interest in and to the Assigned Trademarks. The terms of the Transfer Agreement are incorporated herein by reference. All capitalized terms used in this Trademark Assignment but not otherwise defined herein shall have the meanings set forth in the Transfer Agreement.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, 1,000 Days hereby assigns, transfers, and conveys to FHI Solutions all right, title, and interest in and to the Assigned Trademarks in the United States and all jurisdictions outside the United States, together with the goodwill of the Activities connected with and symbolized by the Assigned Trademarks (including without limitation, the right to renew any registrations included in the Assigned Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Assigned Trademarks, and any priority right that may arise from the Assigned Trademarks), to be held and enjoyed by FHI Solutions as fully and entirely as said interest could have been held and enjoyed by 1,000 had this assignment, transfer and conveyance not been made.

1,000 Days authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations set forth on Exhibit 1 to FHI Solutions as assignee of 1,000 Days' entire right, title and interest therein. 1,000 Days agrees to further execute any documents reasonably necessary to effect this Assignment or to confirm FHI Solutions' ownership of the Assigned Trademarks.
