TRADEMARK ASSIGNMENT

WHEREAS, Pro-Pet, L.L.C. (hereinafter "Pro-Pet"), a Delaware limited liability corporation with its principal office and place of business at 1400 McKinley Road, St. Marys, Ohio 458851821, owned the trademarks in Schedule A with the accompanying trademark registrations (hereinafter "Trademarks");

WHEREAS, the Trademarks were inadvertently and erroneously omitted from the listing of transferred trademarks in the February 18, 2011 Asset Purchase Agreement (hereinafter "APA") between Joy Dog Food and Pro-Pet; and

WHEREAS, both Pro-Pet and Joy Dog Food agree that the Trademarks were unintentionally omitted, and the parties' intention and understanding has been that the Trademarks were transferred under the APA;

NOW, THEREFORE, for good and valuable consideration as described in the APA, receipt and sufficiency of which is hereby acknowledged, Pro-Pet does hereby assign to Assignee *nunc pro tunc* as of December 18, 2020, all rights, title and interest in and to said Trademarks and the registration thereof, together with the goodwill of the business symbolized by said Trademark and with the right to recover and have damages and profits for past infringement, if any.
