## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of December 18, 2020, is made by ACAS, LLC (formerly known as American Capital, Ltd.) ("Agent") in favor of TEASDALE FOODS, INC. a Delaware corporation ("Teasdale") and MESA FOODS, LLC, a Delaware limited liability company ("Mesa", and together with Teasdale, collectively, the "Grantors"). Each of Teasdale and Mesa are referred to herein individually as a "Grantor," and collectively as the "Grantors." Capitalized terms used but not defined herein shall have the meaning ascribed to them, directly or by reference, in the IP Security Agreements, as applicable.

**WHEREAS**, pursuant to the Second Lien Loan Agreement, dated as of October 28, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time), the Grantors and the Agent are parties to the Second Lien Guaranty and Security Agreement, dated as of October 28, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement, (i) Teasdale executed a Trademark Security Agreement, dated as of October 28, 2014, in favor of the Agent ("2014 IP Security Agreement"), which was duly recorded on November 3, 2014, at Reel 5393 Frame 0394 in the United States Patent and Trademark Office, (ii) Mesa executed a Trademark Security Agreement, dated as of June 16, 2016 ("2016 IP Security Agreement"), which was not recorded, (iii) Agent filed an Entity Conversion to evidence the conversion of American Capital, Ltd., a Delaware corporation, to ACAS, LLC, a Delaware limited liability company, which was duly recorded on February 26, 2019, at Reel 6574 Frame 0031 and (iv) Mesa and Teasdale executed a Trademark Security Agreement, dated as of February 26, 2019, in favor of the Agent ("2019 IP Security Agreement", and together with the 2014 IP Security Agreement and the 2006 IP Security Agreement, collectively the "IP Security Agreements"), which was duly recorded on February 27, 2019, at Reel 6575 Frame 0961 in the United States Patent and Trademark Office;

**WHEREAS**, pursuant to the Security Agreement and the IP Security Agreements, each Grantor mortgaged, pledged, hypothecated, and granted to the Agent, for the benefit of the Secured Parties, a Lien on and security interest in (the "Security Interest"), all of its right, title and interest in, to and under the following Collateral of such Grantor: (i) all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule I hereto, (ii) all renewals and extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark, and (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (the "Trademark Collateral"); and

**WHEREAS**, the Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantors and to dissolve those liens and encumbrances created by the IP Security Agreements.


**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Security Interest in the Trademark Collateral created under the Security Agreement and the IP Security Agreements, (b) release the Security Interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademark Collateral. Each Grantor (and any successor to such Grantor, including any person or entity hereafter having any right, title or interest in and to the Trademark

Collateral of such Grantor) is hereby authorized to record this Release in the United States Patent and Trademark Office.
