TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This Termination and Release of Security Interest in Patents and Trademarks (“IP Release”) is made as of December 18, 2020, by MANUFACTURERS AND TRADERS TRUST COMPANY (the “Collateral Agent”) in favor of MI WINDOWS AND DOORS, LLC, a Delaware limited liability company and MILGARD MANUFACTURING LLC, a Delaware limited liability company (successor to Milgard Manufacturing Incorporated, a Washington corporation) (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Term Loan Pledge and Security Agreement among the Grantors, the other grantors from time to time party thereto and the Collateral Agent, dated as of November 6, 2019 (the “Pledge and Security Agreement”), Grantors granted a security interest to the Collateral Agent to secure the satisfactory performance and payment of all the “Secured Obligations” of each Grantor (the “Security Interest”) in certain collateral of such Grantors, including Trademarks and Patents (as defined below);

WHEREAS, each Grantor reaffirmed its intent to grant such security interest in all of such Grantor’s right, title and interest in and to certain Trademarks and Patents pursuant to that certain Grant of Security Interest Patents and Trademarks, which was recorded on November 6, 2019 at the United States Patent and Trademark Office at Reel 6789, Frame 0783 (the “IP Security Agreement”) with the Collateral Agent; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Patents and Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the Secured Parties (as defined in the Credit Agreement, hereby releases, terminates and discharges in its entirety the Security Interest and any and all of its interest in the intellectual property of each Grantor (the “Intellectual Property Collateral”), including, without limitation, the (i) the trademarks, trademark registrations, and trademark applications (“Trademarks”) set forth on Schedule A attached hereto and all reissues, extensions or renewals thereof; (ii) the patents, and patent applications (“Patents”) set forth on Schedule B attached hereto and all reissues, continuations, continuations-in-part and extensions thereof, in each case, together with (iii) all Proceeds of the Trademarks and Patents, (iv) the goodwill of the businesses with which the Trademarks are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks and Patents or unfair competition regarding the same, and hereby assigns, transfers and conveys to each such Grantor any interest in the Intellectual Property Collateral, including the Security Interest.

Capitalized terms used but not defined herein shall have the meanings assigned to them in the IP Security Agreement or the Pledge and Security Agreement, as applicable.

The Collateral Agent shall, at the Grantors' expense, take all further actions, and provide to the Grantors and their successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their successors, assigns and legal representatives may reasonably request in order to confirm effectuate or record this IP Release.


The Collateral Agent authorizes and requests the relevant authority at the United States Patent and Trademark Office to record this IP Release against the Intellectual Property Collateral.

This IP Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this IP Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).


