**TRADEMARK ASSIGNMENT AGREEMENT**

The Assignor agrees to identify and communicate to the Assignee, at the Assignee's request, such documents and information concerning the Trademarks that are within the possession or control of the Assignor, and to provide further assurances and testimony on behalf of the Assignee that may lawfully be required of the Assignee in respect to maintaining the rights in the Trademarks, all without further consideration. The Assignor further agrees to reasonably execute any further documents which may be needed to effectuate or otherwise document this assignment.

This Agreement is governed by the substantive laws of CALIFORNIA, and any disputes will be resolved in state court or federal court sited in CALIFORNIA.


