**CERTIFICATE OF MERGER OF LINIUM, LLC AND NESS USA, INC. INTO NESS
USA, INC.**

UNDER SECTION 904-A OF THE BUSINESS CORPORATION LAW

1. The name of each constituent entity is as follows:

Linium, LLC, a New York limited liability company. The name under which Linium, LLC was originally formed is "Eresources, LLC".

Ness USA, Inc., a Pennsylvania corporation. The name under which Ness USA, Inc. was originally formed is "APAR Infotech Corporation".

2. The date when the certificate of incorporation or articles of organization of the domestic constituent entity was filed by the Department of State is as follows:

Linium, LLC filed its initial articles of organization on April 10, 2000.

3. The name, jurisdiction of (incorporation or formation) and the date of filing of the initial Articles of Incorporation of the foreign constituent and the date when its application for authority was filed by the Department of State, is as follows:

Ness USA, Inc. filed its original Articles of Incorporation in Pennsylvania on August 21, 1997.

The application for authority of Ness USA, Inc. to do business in the State of New York was filed with the Department of State on August 17, 1998.

4. An agreement of merger has been approved and executed by each constituent entity.

5. The name of the surviving corporation is: Ness USA, Inc.

6. Ness USA, Inc. agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation of any domestic or foreign constituent entity, previously amendable to suit in the State of New York, and for the enforcement under the Business Corporation Law, of the right of shareholders or

members of any constituent domestic entity to receive payment for their interests against Ness USA, Inc.; and it designates the Secretary of State of New York as its agent upon whom process against it may be served in the manner set forth in paragraph (b) of Section 306 of the Business Corporation Law, in any action or special proceeding. The post office address to which the Secretary of State shall mail a copy of any process against it served upon him is 300 Frank W. Burr Boulevard, 5th Floor, Teaneck, NJ 07666.

7. Ness USA, Inc. agrees that, subject to the provision of Section 623 of the Business Corporation Law, Section 1005 of the Limited Liability Company Law or any applicable statute, it will promptly pay to the shareholders of each constituent New York corporation and owners of any constituent other business entity the amount, if any, to which they shall be entitled under the provisions of the Business Corporation Law, the Limited Liability Company Law or applicable statute, relating to the right of shareholders, owners and members to receive payment for their shares.

8. The merger shall be effective as of the date of filing.

9. The merger is permitted by the jurisdiction of incorporation and is in compliance therewith with respect to the foreign constituent entity set forth in Item 3 above.

10. The agreement of merger is on file at the corporate headquarters of Ness USA, Inc. the address of which is 300 Frank W. Burr Boulevard, 5th Floor, Teaneck, NJ 07666.
