**TRADEMARK ASSIGNMENT - USA**

**THIS TRADEMARK ASSIGNMENT** (the "Assignment") is made as of this 11th day of December, 2020, by and between Century 21 Department Stores LLC, a New York limited liability company with an address of 22 Cortlandt Street, New York, New York 10007 ("Assignor"), and Gindi C21 IP LLC, a Delaware limited liability company with an address of 175 Broadway, 2<sup>nd</sup> Floor, New York, New York 10007 ("Assignee").

**WHEREAS**, Assignor wishes to sell, assign and convey the Trademarks to the Assignee, and Assignee wishes to purchase and assume the Trademarks.

**NOW, THEREFORE**, for \$10.00 other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby irrevocably assigns, transfers, and conveys to Assignee, and Assignee hereby accepts, all of the Assignor's rights, title, and interests in and to (a) the Trademarks, and, (b) together with the goodwill appurtenant to each trademark and (c) all claims of Assignor to the extent arising out of, or relating to the Trademarks, including all claims, causes of action, rights of recovery, and rights of set-off of Assignor, in each case, of whatever kind or description of any third party solely to the extent arising out of, or relating to the Trademarks. Assignor authorizes the U.S. Commissioner for Patents and Trademarks to record and register this Assignment upon Assignee's request.

2. Assignor agrees to promptly execute all documents, assist in all proceedings, and take any further steps as Assignee may reasonably deem appropriate (at Assignee's sole cost and expense) to effectuate the transfer of the Trademarks to Assignee and the perfection, registration, and recordation of the rights of Assignee thereto.


3. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

4. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


