RELEASE OF SECURITY INTEREST
IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of as of December 22, 2020 (the "Effective Date") from Royal Bank of Canada, as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent") to 99 Cents Only Stores LLC (the "**Grantor**").

WHEREAS, the Grantor was party to a Security Agreement by and between the Grantor, the other loan parties party thereto and the Collateral Agent (as amended, modified or supplemented in accordance with its terms, the "Security Agreement") dated as of January 13, 2012 in favor of Collateral Agent and for the benefit of certain lenders;

WHEREAS, pursuant to the Security Agreement, the Grantor and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of January 13, 2012 (the "Trademark Security Agreement", and all capitalized terms used, but not defined, herein have the definition assigned to them in the Trademark Security Agreement);

WHEREAS, pursuant to the Trademark Security Agreement the Grantor granted to Collateral Agent, for the benefit of the lenders, a security interest in and to all of the Grantor's right, title and interest in the Grantors' Trademarks constituting IP Collateral, including the Trademarks listed on Exhibit A attached hereto (the "Released Marks");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 17, 2012, at Reel 4699, Frame 0445;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of itself, its successors, legal representatives and assigns, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, (i) hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantors, all of Collateral Agent's right, title and interest in and to the Released Marks, and all causes of action for past infringement, if any; and (ii) terminates the Trademark Security Agreement.

This Release and the rights and obligations of the parties hereunder shall be construed in accordance with and be governed by the law of the State of New York.

IN WITNESS WHEREOF, Collateral Agent has executed this Release of Security Interest in Trademarks as of the Effective Date.
