3. The agreement of merger (the "**Agreement of Merger**") has been approved and executed by each limited liability company.

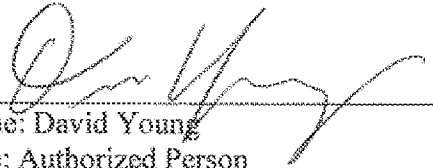
4. As of the effective time of the merger, the name of the Surviving Limited Liability Company shall be Trifecta Multimedia, LLC.
