RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE dated as of December 22, 2020 (this "Release") is made by BANK LEUMI USA, a California corporation, (in such capacity, together with its successors and permitted assigns in such capacity, the "Secured Party") under that certain Trademark Security Agreement, dated as of June 2, 2017 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") between HEFFERNAN INSURANCE BROKERS, a California corporation ("HIB"), SOCIUS INSURANCE SERVICES, INC., a California corporation ("SIS"), and TANGRAM INSURANCE SERVICES, INC., a California corporation ("TIS") and together with HIB, collectively and jointly and severally referred to herein as "Grantor") and the Secured Party. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded at the United States Patent and Trademark Office ("USPTO") on June 6, 2017 at Reel 6077 and Frame 0680, the Grantor granted to the Secured Party a security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, including those set forth on the attached Schedule I.

WHEREAS, the Grantor has requested and the Secured Party has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral solely in respect of HIB and TIS (the "Released Collateral"). For the avoidance of doubt, in no event shall this release apply to any Trademark Collateral of SIS and the term "Released Collateral" shall not apply to any Trademark Collateral of SIS.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Secured Party in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
